However, for the Session Organizer, NCS Steering Committee Member, and Presenters together with their designated Reactors/Discussants shall be exempted from paying the required registration fee. Expenses for registration and transportation shall be subject to usual accounting and auditing rules and related administrative issuance (AO 103) and availability of funds.
