This conference is being convened by the DENR and the Department of the Interior and Local Government (DILG), together with the Haribon Foundation for the Conservation of Natural Resources and Birdlife International in cooperation with the Ateneo School of Government, the La Salle Institute of Governance and the UP Center for Local and Regional Governance.

All conference-related expenses that include registration, food and accommodation shall be shouldered by the organizers. Transportation expenses for bus, plane or boat to and from Manila may likewise be shouldered by the organizers on reimbursement basis, at the conference venue. For participants coming from Manila, Southern Luzon, Visayas and Mindanao, transportation from Manila to the venue and back shall be provided. Other expenses incurred shall be chargeable against personal accounts pursuant to Presidential Administrative Order No. 103 dated 31 August 2004 and DENR Memo Order No. 2004-11 dated 8 October 2004 prescribing fiscal discipline measures. No representative/s shall be allowed.

This Order takes effect on the dates specified.
