Their specific responsibilities as Institution Partners are the following:

- 1. To provide guidance in the planning, implementation and reporting of the APP, especially on matters pertaining to organizational goals, structures and policies that affect and affected by the chosen area of study;
- 2. To endorse the student's selected APP and certify to its completion at the end of the APP implementation phase;
- 3. To provide institutional support through reasonable access to needed information, contacts and resources for the APP;
- 4. To establish a mutually agreeable timetable of activities with the student;
- 5. To attend and participate in the Orientation Session for the APP Institutional Partners and APP proposal and Final Report Defenses; and
- 6. To closely collaborate with the Faculty Adviser upon student's initiative.

All expenses to be incurred by the DENR officials/employees that are related to their designation as Institutional Partners (IP's) shall be charged against their respective offices and the student's thesis allowance.

This order is in effect for the duration of the Action Plan and Project (APP) timetable only.
