However, they are required to work in their respective offices except for their day off privileges of one (1) day off per week from first semester 2020-2021 to first semester 2021-2022; and two (2) days off per week for second semester 2021-2022.

They shall receive full scholarship grant under the DENR Local Scholarship Program pursuant to the Memorandum of Agreement (MOA) between the DENR and the PUP. Further, the DENR shall continue to pay their salaries, and other emoluments and adjustments, subject to the existing scholarship guidelines and the usual accounting and auditing rules and regulations.

As recipients of scholarship grant, they are required to sign a Scholarship Service Obligation Contract with DENR (copy attached) and submit to the Career Development Division, Human Resource Development Service, copy furnished their respective Heads of Offices through their HR/Personnel Section/Unit. It shall serve as basis for evaluation of performance as regards to compliance with scholarship rules and regulations.

This Order takes effect immediately and shall remain in force until completion of the said Program.
