DEFINING THE INTERNAL ORGANIZATIONAL SET UP OF THE DENR AS CHAIRPERSON OF AND SECRETARIAT TO THE INTER-AGENCY TASK FORCE BUILD BACK BETTER AND ITS ORGANIZATIONAL STRUCTURE

In the interest of the service and pursuant to Executive Order No. 120, series of 2020 "Strengthening Rehabilitation and Recovery Efforts in Typhoon-Hit Areas through the creation of the Build Back Better Task Force" establishing the Build Back Better Task Force (TF BBB) for post-disaster rehabilitation and recovery efforts in areas affected by typhoons, the DENR internal organizational set up as Chairperson of and Secretariat to the Task Force (refer to attached Annex A) is hereby defined as follows:

1. Focal Persons for the Key Result Areas (KRAs) of the Task Force

The following Undersecretaries and Assistant Secretaries are hereby designated as Focal Persons and Assistant Focal Persons of each of the identified six (6) KRAs on Recovery, Rehabilitation and Reconstruction.

The Focal Persons and their Assistants shall be responsible for coordination with the concerned Agencies designated as Head of each of the six (6) KRAs on the following tasks, among others:

- a. formulation of the Implementation Plan, budgetary requirement and funding proposal, initially for the Cagayan Valley, Bicol Region and Marikina;
- b. provision of support to the KRA Head and member agencies and participation of DENR offices in the conduct of activities to implement the KRA Implementation Plan;
- monitoring of the activities and accomplishment of the activities of the KRA
 to identify concerns and challenges and required actions to address them;
 and

d. submission of regular report including recommendations on their respective KRA assignment to the TF BBB Chairperson/DENR Secretary through the TF BBB Secretariat.

The DENR as head of KRA 6 shall lead the performance of the above responsibilities and ensure that its member agencies are involved and mobilized.

2. Task Group Heads for Ground Operation

To provide support to the KRA Heads by (a) overseeing the implementation of activities on the ground by the KRA Heads and member agencies; and (b) ensuring coordinated and harmonized actions by concerned agencies and their field offices, Task Groups are hereby formed in the area of Cagayan Valley, Bicol Region and Marikina. The Task Groups shall coordinate with the concerned DENR field offices through the Undersecretary for Field Operations and Regional Executive Directors.
