Except for Mr. Diosdado M. Contillo and Mr. Luciano B. Cabauatan, whose designation to the position is internally created, the herein designated officers shall be entitled to claim Representation and Transportation Allowance (RATA) and all other emoluments on reimbursable basis, subject to existing accounting and auditing rules and regulations, upon actual assumption to duty in this designation.

They shall inform the undersigned in writing, through channels, of their compliance with this Order for record purposes.
