AUTHORIZING THE CONDUCT OF BIATF ALTERNATES MEETING AND PRINCIPALS MEETING ON MARCH 17-18, 2021 IN BORACAY ISLAND

The meeting shall be conducted through mixed face-to-face and virtual conference in accordance with the IATF protocols on social distancing and observance of minimum health and safety measures. The Chair and Co-Vice Chairs of the BIATF shall lead the meeting in Boracay Island with the Head of the BIATF Secretariat and other members who shall be attending the face to face meeting. Other participants shall join the virtual conference.

The Boracay Inter-Agency Rehabilitation Management Group (BIARMG) support personnel shall provide administrative and secretariat support to the meeting.

All expenses to be incurred relative to the above meeting including logistical requirements necessary in the conduct of video conference and remote participation of other members, shall be charged to funds of the BIATF. Transportation expenses of participants

to/from Boracay Island shall be charged against respective offices while transportation expenses of Secretariat and support staff shall be charged against BIATF funds.

The Secretariat shall inform the respective parties and participants through advisories on further arrangement about the meeting. A report on the Meeting shall be submitted to the BIATF Chair through the undersigned fifteen (15) days after the meeting.
