**SUBJECT : AUTHORIZING THE CONDUCT OF A LEARNING
EVENT ON THE ESTABLISHMENT OF BAMBOO
PLANTATION IN MINING AREAS**

In the interest of the service and per directive of DENR Secretary Roy A. Cimatu, the conduct of a Learning Event on the Establishment of Bamboo Plantation in Mining Areas is hereby authorized on March 11, 2021 for the online lectures, and on the agreed dates between March 12, 2021 to April 30, 2021 for the hands-on demonstration at the respective areas of jurisdiction. The event aims to provide inputs on the concepts and principles of bamboo propagation, plantation establishment and maintenance.
