The Workshop primarily intends to bring together the concerned Bureaus, Attached Agencies, and other Offices to undertake the streamlining and harmonization of process flow of permits and issuances for the energy projects for each of the identified "scenarios" in compliance with EVOSS Act.

The OIC-Director for Policy and Planning Service is authorized to amend and reschedule the activity in case of unavailability of the resource persons, venue, or conflict of schedule with other activities of the Department.

A written report shall be submitted to the Undersecretary for Policy, Planning and International Affairs and Undersecretary for Field Operations and Environment, through the Assistant Secretary for Policy, Planning and Foreign-Assisted and Special Projects and OIC-Assistant Secretary for Field Operations-Luzon, copy furnished the undersigned fifteen (15) days after the activity.

This Order shall take effect on the dates specified herein.
