
Secretariat support shall be provided by the Caves, Wetlands and other Ecosystems Division (CAWED) of the Biodiversity Management Bureau (BMB).

The BMB shall submit to the undersigned a consolidated report on the activity through the Human Resources Development Service in fifteen (15) days after the completion of the event.
