The Health and Wellness Program – Focal Person (HWP-FP) shall perform the following:

- i. Disseminate all information relative to the conduct of HW activities to their respective offices;
- ii. Collect/gather necessary data/information from their respective offices relative to HW activities (i.e., vaccination status);
- iii. Assist the HWP team in the implementation of HWP activities should the need arise;
- iv. Ensure that all minimum standard health protocols by the Inter-Agency Task Force (IATF) for the Management of Emerging Infectious Diseases and Department of Health (DOH) on COVID-19 are strictly followed by the employees and guests in the respective areas of concern;
- v. Provide first aid in case of health emergencies;
- vi. Assist in monitoring of the health and wellness of the employees such as, but not limited to Blood Pressure check;

vii. Attend/participate to all related activities of the HWP to enhance their competencies relative to their functions as HWP-FP.

The Director of the Human Resource Development Service shall oversee/supervise the implementation of this order.

This Order takes effect immediately.
