**SPECIAL ORDER**

**SUBJECT: AUTHORIZING THE CONDUCT OF THE 2021 IUCN ASSESSMENT WORKSHOPS ON PHILIPPINE SNAKES AND LIZARDS AND THE PARTICIPATION OF CERTAIN DENR PERSONNEL**


