At the end of the webinar participants are required to come up with an action plan.

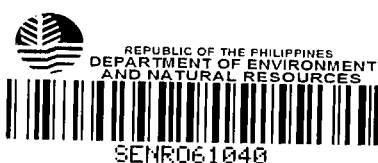

All expenses to be incurred in relation thereto (i.e. food, honorarium of the resource persons, supplies and materials, collaterals, miscellaneous and other allowable incidental expenses) shall be charged against TAK funds subject to the usual budgeting, accounting and auditing rules and regulations.

Activity reports shall be submitted to the undersigned, thru channels, fifteen (15) working days after conduct of said activity.

The Executive Director of the Task Force Tayo Ang Kalikasan is hereby authorized to amend the line-up of participants and /or reschedule the activity in case of conflict with other activities of the Department.
