
The BMB Director may also invite experts from other relevant Government Agencies and Non-Government Organizations to serve as resource persons during the Capacity Building. On the other hand, the concerned Regional Executive Directors may also invite Indigenous Peoples representatives from the Management Board of the afore-mentioned protected areas and other members of the Local Project Management Team.

The Capacity Building shall be conducted online via Zoom. The BMB Director is also authorized to change the date of the above activities if deemed necessary due to unforeseen events/circumstances.

All expenses to be incurred in the activity shall be charged against the National Parks Division's fund subject to the usual accounting and auditing rules and regulations.

A report shall be submitted by the National Parks Division to BMB Director thru the BMB's Human Resource Development Unit within fifteen (15) days after completion of the activity.

This Order shall take effect on the dates specified herein.
