In addition to the above-mentioned staff, a total of thirty six (36) selected CBFM-People's Organization (PO) officers/members from Regions 2, 3, 6, 7, and 10 will serve as the primary training participants based on FMB and AFoCO criteria. Further, resource persons from other National Government Agencies, Non-Government Organizations, and the Private Sector will be invited to provide lectures/learning sessions related to Bamboo Product Development and Marketing.

All expenses to be incurred such as, but not limited to, meals/ snacks, mobile data/ internet connection costs, supply/ materials, and other fees/ expenditures by DENR Region and FMB staff, resource persons and CBFM-PO participants shall be charged against AFoCO, respective Regional offices and FMB/CBFM-CARP funds subject to usual accounting and auditing rules and regulations.

The Director of the Forest Management Bureau is authorized to reschedule the activity and/or change the venue in case of conflict with other activities of the Department.

A report shall be submitted to the undersigned within fifteen (15) days after the completion of the activity.

This Order takes effect on the dates specified therein.
