

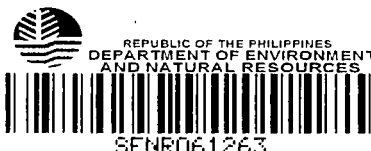

Personnel included in the face-to-face activity must observe proper protocol on workplace, health sanitation and safety according to the IATF guidelines.

A report shall be submitted by the BMB to the Secretary, through the undersigned within fifteen (15) days after the completion of the event.

This Order takes effect immediately and is automatically revoked upon completion of the aforesaid activities.
