
All expenses to be incurred in relation to the above-mentioned activity such as food, accommodation, transportation, and COVID-19 swab test shall be charged against BMB-CMD funds subject to the usual accounting and auditing rules and regulations. Further, travel expenses, per diem, and COVID-19 test of the participants from the Regional and Field counterparts shall be charged against their respective Offices.

Attendance on the above-mentioned training activity, including Saturdays and Sundays, shall be considered as official time. Contract of Service employees attending the activity who will incur official time in excess of 22 days for this month shall be entitled to compensatory time-off privilege to be used within the year, equivalent to the incurred excess in official time for the month of this event.

The BMB Director may reschedule the date and time of the activities, as necessary for reasons such as availability of resource speaker/dive instructor, inclement weather conditions, natural disasters, and intermittent COVID-19 travel restrictions, as well as conflict of schedule with other priority programs of the DENR and BMB.

A report shall be submitted to the undersigned within fifteen (15) days after the completion of the diving training.

This Order shall take effect on the dates specified herein.
