In the interest of the service and as part of the celebration of National Bicycle Day by virtue of Presidential Proclamation no. 1052, and Clean Air Month, respectively and to promote clean air in Metro Manila through the use of non- motorized mode of transportation as well as to mobilize the cycling community to be part of our continues advocacy in Manila Bay rehabilitation the conduct of the 7th National Bicycle Day on 28 November 2021 at the Centennial Park, Brgy. Bagumbayan North, Navotas City is hereby authorized.

The participation of all personnel concerned in the said activity shall be on official time with a one (1) day offsetting privilege to be used until December 31, 2021.

In compliance with COVID-19 Inter-agency Task Force for the Management of Infectious Diseases Guidelines, limited number of volunteers shall be mobilized during the conduct of the activity. Further, health measures and social distancing protocols will be strictly enforced.

Expenses to be incurred during the conduct of the event shall be charged against funds of the SCIS subject to the usual accounting and auditing rules.

The Undersecretary for Solid Waste Management and Local Government Units Concerns is authorized to reschedule the activity in case of conflict with other activities of the Department.

A report shall be submitted to the undersigned within fifteen (15) days after the activity.
