SUBJECT : DESIGNATION OF SECTION CHIEFS UNDER THE DIVISIONS OF THE KNOWLEDGE AND INFORMATION SYSTEMS SERVICE

In the interest of the service and to ensure accountability, efficient completion and delivery of services of Knowledge and Information Systems Service (KISS) including development of information systems and knowledge product, management of network infrastructure and provision of statistical and geospatial database functions, the following personnel under the Divisions of the KISS are hereby designated as Section Chiefs.

1. Information Systems Division (ISD)

a) Planning, Systems Analysis and Design Section

Section Chief: Dennis Guy M. Segovia, Information Systems Analyst III

The section is responsible for the information systems architecture, research and development, systems analysis and design, Information Systems Strategic Plan (ISSP) development, information systems policy development and project management.

b) Systems Development and Data Security Section

Section Chief: Nasser Lawrence B. Luminog, Information Systems Analyst III

The section is responsible for the systems development, website development and management, periodic maintenance, and backup and data security.

c) Quality Assurance, Operations and Technical Support Section

Section Chief: Elizabeth L. Arcinas, Information Systems Analyst III

The section is responsible for the quality assurance testing, information systems audit/control, information systems deployment, information systems operations and information systems User Support.

2. Network and Infrastructure Management Division (NIMD)

a) Network Infrastructure Management and Operations Section

Section Chief: Eugene C. De Guzman, Information Systems Analyst III

The section is responsible for the operationalization, maintenance and consistency of the network infrastructure.

b) Network Infrastructure Data Management, Storage and Technical Support Section

Section Chief: Nizethal A. Matias, Computer Programmer III

The section is responsible for storage management and timeliness, consistency and effectiveness in undertaking end-user support queries and requests.

c) Network Infrastructure Asset Management Section

Section Chief: Enielbert E. Estefanio, Information Systems Analyst III

The section is responsible for the procurement and maintenance of IT assets and ensures that the delivery of services from infrastructure is provided in a cost-effective manner.

3. Statistics and Data Resource Management Division (SDRMD)

a) Geospatial Information Management Section

Section Chief: Roja Guia S. Bati-on, Information Officer III

The section is responsible for the integration of statistical and spatial data, administration of DENR control map geodatabase and server, and provision of technical support on GIS software installation and authorization.

b) Data Management and Coordination Section

Section Chief: Liberty D. Fernandez, Statistician III

The section is responsible for the development, design, management and maintenance of ENR database, consolidation of ENR data/statistics, and coordination and participation to the interagency statistical activities.

c) Statistics and Data Analysis Section

Section Chief: Arvin R. Reginio, Statistician II

The section is responsible for provision of technical assistance and support to DENR offices requiring statistical analysis, development of census or surveys in collecting primary data for its projects and programs, and development of statistical data into knowledge products.

The above personnel shall supervise the Sections as assigned and shall perform duties and responsibilities appurtenant to their designation.

This Order shall take effect immediately and supersedes all orders inconsistent herewith.
