SPECIAL ORDER No. 2021 - 810

**SUBJECT** 

CREATION OF AN AGENCY SCREENING COMMITTEE FOR THE EVALUATION OF ELIGIBILITY BENEFITS UNDER THE MAGNA CARTA FOR SCIENTISTS AND OTHER SCIENCE & TECHNOLOGY PERSONNEL (R.A. No. 8439 AS AMENDED)

In the interest of service and to evaluate the eligibility of the applicants from the DENR for the benefits of Magna Carta for Scientists, and other S&T personnel in the government as amended, the Agency Screening Committee (ASC) is hereby created. The Committee shall primarily assist the Secretary in evaluating the qualifications of each applicant for certification of eligibility.

Pursuant to Section XI of the Department of Science and Technology Administrative Order No. 009 s. 2020, the DENR- ASC shall be composed of the following:

Chairperson : The Assistant Secretary supervising HRD

Vice-Chairpersons : The Director, Human Resource Development Service

The Director, Ecosystems Research and Development

Bureau

Members : The Director, Financial and Management Service

The Director, Environmental Management Bureau (EMB)
The Director, Mines and Geosciences Bureau (MGB)
The Chief, Planning and Information and Communications

Technology Division – ERDB

Secretariat : The Chief, Administrative, Finance and Management

Division – ERDB (Head)

One (1) representative each from Personnel Division/HR

Sections/Units of DENR CO, EMB, MGB and ERDB

The functions of the DENR-ASC are as follows:

1. Screen and evaluate applicants;

2. Submit to the Secretary its findings and recommendations for approval;

- 3. Monitor the continuity of the S&T activities-related functions of the personnel and make a report to the Secretary in cases of promotion, and/or transfer and termination or automatic revocation of the certification before the expiration of the certification issued; and
- 4. Perform such other-related functions as may be necessary to achieve the purpose for which the ASC was created.

All expenses that will be incurred shall be charged against available DENR funds.

This Order takes effect immediately and supersedes all previous orders inconsistent herewith.
