All DENR offices, at the Central, Bureaus, Attached Agencies and Regional levels, are directed to organize their respective support activities and advocacy campaigns in support of the Women’s Month, chargeable against respective office funds. Report of documentation of all activities conducted shall be submitted to the National GAD Focal Point System, by end of April 2022.


All expenses to be incurred in relation to the aforementioned Central Office activities shall be charged against the GAD funds subject to the existing accounting and auditing rules and regulations.

Safety and health protocols as prescribed in the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines dated 19 August 2021 shall be strictly observed, such as but not limited to wearing of face mask and face shield and observance of social distancing.

The Undersecretary for Finance, Information System and Climate Change, as Chairperson of the DENR National GAD Focal Point System is authorized to amend and re-schedule the planned activities in case of conflict with other activities of the Department.

A report shall be submitted to the undersigned within fifteen (15) days after the event.
