A written report shall be submitted to the Secretary, through the Undersecretary for Field Operations-Mindanao, copy furnish the undersigned, fifteen (15) days after the activity.

The Undersecretary for Field Operations Mindanao is authorized to reschedule the conference in case of conflict with other activities of the Department.
