**SUBJECT: AUTHORIZING THE CONDUCT OF DATA GATHERING (INTERVIEW OF PROSPECTIVE WITNESSES AND OCULAR INSPECTION) IN PREPARATION FOR THE PLANNED FILING OF COMPLAINTS FOR REVERSION AND/ OR CANCELLATION AGAINST TITLEHOLDERS OF THE ISLANDS OF FUGA, MABBAG AND BARIT**
