SUBJECT: AUTHORIZING THE ATTENDANCE OF MS. MARY ANTONETTE MALALUAN OF DENR CARAGA AND MS. JUDILYN ARREZA OF THE DEL CARMEN FISHERFOLKS ASSOCIATION AS PART OF DENR GUESTS OF THE CABINET CLUSTER ON CLIMATE CHANGE ADAPTATION, MITIGATION AND DISASTER RISK REDUCTION PRESENTATION IN THE DUTERTE LEGACY SUMMIT ON MAY 30, 2022

In the interest of the service and to effectively communicate, promote and showcase the government's efforts to bring real change to the lives of Filipinos in the 2022 Duterte Legacy Summit, the attendance of **Ms. Mary Antonette Malaluan** of DENR Caraga and Ms. Judilyn Arreza of Del Carmen Fisherfolks Association (DelCaFia), in Del Carmen, Siargao Island as part of DENR guests of the Cabinet Cluster on Climate Change Adaptation, Mitigation and Disaster Risk Reduction (CCAM-DRR) is hereby authorized on May 30, 2022 at the Philippine International Convention Center, Pasay City.

The summit will be the culmination of the Duterte Legacy campaign, which aims to promote the Duterte administration's landmark achievements. It will also serve as the last report of the cabinet officials to the public by highlighting the accomplishments, policies, and projects of the administration, as well as the reforms it has introduced to enhance the lives of Filipinos. The beneficiaries/guests of the respective programs and projects are requested to attend physically to share their personal experiences and testimonies.

Ms. Malaluan's roundtrip air tickets shall be chargeable against the funds of DENR Caraga, while Ms. Arreza's roundtrip air tickets shall be chargeable against the funds of the DENR Central Office. Costs for food, accommodation and other related expenses during the technical dry run and other preparations for the event on May 29, 2022 and on the actual summit until return to origin shall be chargeable against DENR Central Office funds, subject to the existing accounting and auditing rules and regulations.

A report shall be submitted to the undersigned within fifteen (15) days after completion of the activity.

This Order shall take effect on the date herein specified.
