**SUBJECT: AUTHORIZING THE CONDUCT OF THE 2<sup>nd</sup> DENR-PCMC BLOODLETTING ACTIVITY FY 2022 AND MEMORANDUM OF AGREEMENT (MOA) SIGNING ON 01 JUNE 2022**

In the interest of the service and in view of continuing partnership with the Philippine Children's Medical Center (PCMC) to save lives through blood transfusion and to generate adequate safe blood supply during this COVID-19 pandemic, the conduct of the 2<sup>nd</sup> DENR-PCMC Bloodletting activity FY 2022 and Memorandum of Agreement (MOA) Signing is hereby authorized on 01 June 2022 at the Public Assistance Unit, Ground Floor, DENR Main Building.

The following offices are authorized to mobilize their respective personnel to participate and in the activity:

The Strategic Communication and Initiatives Service (SCIS) in partnership with the DENR Association of Career Executives (ACE) shall take the lead in the conduct of the overall activity and may coordinate with other concerned offices to join in the said activity.


Observance of minimum public health and safety protocols set by the Inter-Agency Task Force for the Management of Emerging Infectious Diseases such as wearing of face masks and physical distancing shall be strictly imposed throughout the conduct of the activity.

All expenses to be incurred in relation to the activity shall be charged against SCIS-Strategic Alliance and Environmental Partnership Division (SAEPD) funds subject to the usual accounting and auditing rules and regulations.

Successful blood donors shall be entitled to one-day offsetting privilege to be used until 29 December 2022.

The Undersecretary for Policy, Planning and International Affairs, Supervising Undersecretary for Strategic Communication and Initiatives Service is authorized to reschedule the activity in case of conflict with other activities of the Department.
