SUBJECT : DESIGNATION OF TECHNICAL EXPERTS AND REPRESENTATIVES FOR THE DENR BUILDING CONSTRUCTION MANAGEMENT COMMITTEE (DBCMC) AND DEFINITION OF THEIR DUTIES AND RESPONSIBILITIES

- Represent their respective Offices as well as Offices within their areas of responsibility in the regular meetings of the DBCMC;
- Streamline the communication within their areas of responsibility; and
- Assist in the implementation of DBCMC goals, strategies and activities within their areas of responsibility.

The aforementioned Technical Experts and Representatives are encouraged to actively participate in all activities of the DBCMC as necessary. At no instance, a representative of an Office other than mentioned in this Order shall be allowed to attend the activities of the DBCMC. Any amendments to this Order shall be endorsed in writing by the concerned Head of Office.

This Order takes effect immediately and supersedes all issuances inconsistent herewith.
