- 2. They shall ensure that TS financial reports and other required documents are posted in the prescribed format and order for easier validation and checking;
- 3. They shall ensure the timely uploading and/or updating of the required TS reports and other documents based on a schedule set by the Director of the Strategic Communication and Initiatives Service, being the designated DENR TS Focal Point;
- 4. They shall ensure the correctness of links to the TS reports and documents based on the guidelines issued by the Department of Budget and Management (DBM);
- 5. They shall ensure the timely submission of means of verification (MOVs) which is the screenshot of the uploading page, with date of uploading, to SCIS through email at denr.transparencyseal@gmail.com; and
- 6. Perform other functions as may be assigned by the DENR Focal Point.

Expenses to be incurred in the performance of the above functions shall be charged against their respective agency funds, subject to the usual accounting and auditing rules and regulations.

This Order takes effect immediately and revokes all previous orders inconsistent herewith.
