**SUBJECT: AUTHORIZING THE CONDUCT OF THE 5<sup>th</sup> ANNUAL BETA SIGMA ANNIVERSARY RIDE: MANILA BAYWALK DOLOMITE BEACH CLEAN- UP RIDE**

In the interest of the service, in support of the DENR's ongoing Manila Bay clean-up Program and to mobilize the cycling and environmental enthusiast sectors to protect and conserve the environment while maintaining a healthy lifestyle, the Task Force Tayo ang Kalikasan in coordination with the Strategic Communication and Initiatives Service, Manila Bay Coordinating Office, DENR-NCR Metropolitan Enforcement Office – West and the Beta Sigma Malmon Bikers Cycling Club is hereby authorized to facilitate the 5<sup>th</sup> Annual Beta Sigma Fraternity Anniversary Ride through a Bike Ride from the DENR Central office to the Manila Bay Dolomite Beach followed by a coastal clean-up activity on 28 August 2022, Sunday at 5:00 AM.

Observance of the minimum public health and safety protocols set by the Inter-Agency Task Force for the Management of Emerging Infectious Diseases such as wearing of face masks and physical distancing shall be strictly imposed throughout the conduct of the activity.

All expenses incurred during this event shall be chargeable to DENR Task Force Tayo ang Kalikasan funds, subject to the usual accounting and auditing rules and regulations.

A report containing highlights and recommendations shall be submitted to the undersigned fifteen (15) days after completion of the activity.

Participants shall be entitled to one-day offsetting privilege to be used until 29 December 2022. The Undersecretary for Policy, Planning and International Affairs, Supervising Undersecretary for Strategic Communication and Initiatives Service is authorized to reschedule the activity in case of conflict with other activities of the Department.
