

A Consolidated Report on the Training of Trainers shall be submitted by KISS to the Undersecretary for Finance, Information Systems and Climate Change with action plan, activities and timeline for rollout and implementation of the system in the Central and Regional Offices.

All expenses and cash advances to be incurred for this workshop shall be charged against KISS - DENR funds subject to the usual accounting and auditing rules and regulations. The Director of Knowledge and Information Systems Service is hereby authorized to adjust the date and venue of the activity as exigencies of the office may warrant. A report on the activity shall be submitted to the undersigned fifteen (15) days by the Information Systems Division after the conduct of the workshop.
