STATISTICAL CONCERNS AND COORDINATION**

In the interest of the service and in order to effectively coordinate the implementation of statistical and data management policies, programs, and activities of the Department and to ensure compliance with requirements of RA 10625 or the Philippine Statistics Act of 2013, the Technical Committee on Statistical Concerns and Coordination (TCSCC) is hereby reconstituted:


The Technical Committee shall be the coordinating body on all statistics and data management concerns of the Department and shall have the following specific functions:

1. Recommend statistical policies, plans, and programs of the Department, including inputs to the Philippine Statistical Development Program (PSDP);
2. Provide technical input on statistical issues and concerns and compliance to requirements of the Philippine Statistical System (PSS) through the Philippine Statistics Authority (PSA) and the Inter-Agency Committee on Environment and Natural Resources Statistics (IACENRS);
3. Provide recommendations to facilitate Environment and Natural Resources (ENR) data management, sharing of statistics, and linking of information systems across the DENR organization to ensure accessibility of information;
4. Support the development, compilation and analysis of the Natural Capital Accounts (NCA);
5. Recommend capacity development and training programs based on new policies, strategies, and requirements for ENR data (including green assessment, and ecosystems valuation, among others) and to upgrade to new statistical approaches and data analytics;
6. Facilitate the conduct of regular meetings with members of the Technical Committee alternating as host; and
7. Participate in the yearly conduct of the PSS National Statistics Month (NSM) and recommend activities for the NSM.

The Technical Committee shall be represented by all offices producing ENR-related statistical output. As such, newly-created offices in the Department with the said function shall be automatically deemed as new members of this committee.

The technical committee shall call on other DENR personnel, offices, and agencies in the performance of its function and during meetings which shall be held at least once every quarter or as the need arises. The SDRMD shall provide Secretariat support to the Technical Committee.

This Order shall take effect immediately and supersedes Special Order No. 1185 s. 1994 and all orders inconsistent herewith.
