
Expenses to be incurred for food and accommodation and other incidental expenses shall be charged against the FMP funds (Fund 102) of the FMB/CPMO, while the travel and transportation expenses of the participants shall be charged against their respective Offices, subject to the usual accounting and auditing rules and regulations.

All safety and health protocols and prescribed minimum health standards such as but not limited to wearing of face mask and face shield, and observance of social distancing as well as prescribed guidelines on the implementation of community quarantine in the country shall be strictly observed for the entire duration of the activity.

The respective FMP Provincial Project Management Office (PPMO) shall serve as the Secretariat of the activity. A report shall be submitted to the undersigned (through FMP Central Project Management Office for consolidation) within fifteen (15) days after the conduct of the said activity.

The FMB Director is authorized to change the date and venue of the said activity if exigency of the service requires.
