The participants to the 15th NCS should be fully vaccinated against COVID-19 to conform to the minimum health and safety requirements. Participants need to present their vaccination card upon entering the NCS venue. On the other hand, unvaccinated or partially vaccinated are required to present a negative RT-PCR result done within 48 hours, or a negative antigen test result done on the same day.

The registration fee for each participant of the DENR Central Office, Bureaus, Attached Agencies and Regional Field Offices shall be charged against their respective office funds. The government rate per participant are as follows:
