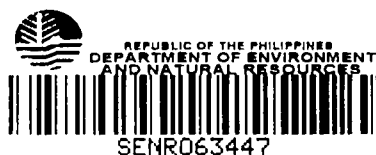
A report shall be submitted to the undersigned within fifteen (15) days upon completion of the activity.
