Participants are instructed to prepare a presentation of their final output with the following information: a.) short description/importance of the assessed watershed, b.) objectives in conducting the assessment, c.) methods used in map processing, generation and analysis, d.) results and impact of vulnerability in the watershed, and e.) recommendations/mitigating measures. The participants will be divided into three clusters for the break-out sessions to discuss/identify which among the regional outputs within their cluster will be reviewed and evaluated by the group. Selected output will then be revised based on the comments of the group and will be presented in the plenary (ERDB VA team) for perusal.

DENR Regional focal will present the following: a.) regional progress (based from the 131 watershed-universe, how many has WCVA and IWMP) and b.) utilization of the VA results (results were used by LGUs, IWMPs, NRDDM Plans, etc.)

The participants are also requested to submit digital copy of the VA report and maps of their target watershed a week before the activity.

All expenses to be incurred, such as venue, food and travelling expenses of ERDB Main office and research centers shall be charged against ERDB funds while travelling expenses of FMB and regional participants shall be chargeable against their respective offices subject to the usual accounting and auditing rules and regulations.

A report shall be submitted to the undersigned fifteen (15) days after the activity.

The ERDB Director is hereby authorized to reschedule the date of the activity as warranted by the situation.

This Order shall serve as their Official Travel Order and shall remain in force until the conclusion of the activity.

This Order shall take effect on the dates herein specified.
