As such they shall perform their duties in accordance with their designations. They shall participate in the periodic drills of the department. The team shall serve as the emergency response team during earthquakes, fire, and other calamities; and also during any untoward incidents that may occur any time in the area/DENR building.

The Damage Assessment and Hazardous Materials Unit shall assess/evaluate environmental damage and provide recommendations for containment/control of the incident. All GSD maintenance and other abled- personnel shall assist in damage control, restoration and clearing operation.

The team shall hold a regular monthly meeting in order to assess the capabilities and needs of the department and to evaluate readiness to respond to all types of emergencies/disasters. The DDRT shall participate in disaster preparedness planning including the service continuity of the DENR. Representatives/proxy during the meeting shall not be allowed. For regular employees listed herein, their commitment and participation must be reflected and part of their Individual Performance Commitment Review (IPCR); while for the Contract of Service, the duties delegated to them in accordance with the above shall be considered as their additional task.

Employees with Medical Background and emergency response training are encouraged to be part of the team on an "On Call" basis and as the need arise. They shall inform the secretariat to include them in the roster of personnel with such skills.


All members of the team and DENR employees regardless of the status of their employment must be provided with personal protective equipment such as hard hat, whistle, flashlights and emergency kit to include "Go Bag" containing three-day survival needs which will be chargeable against DENR funds.

The Office of the Director for Administrative Service shall ensure that an emergency vehicle and a driver shall be assigned on a standby daily basis to respond to immediate needs of DENR employees.

The Incident Commander shall submit a monthly situation report to the Secretary through the undersigned. Likewise, the Incident Commander shall submit regular bulletins and final incident report in the event of occurrence of emergency/disasters.

All other expenses to be incurred in relation to DENR Disaster Response Team shall be chargeable against DENR Funds subject to the usual accounting and auditing rules and regulations.

This Order supersedes previous issuances and takes effect immediately.
