A Consolidated Training of Trainers report shall be submitted by KISS to the Undersecretary for Finance, Information Systems and Climate Change with an action plan and timeline for the implementation of the System in the Central and Regional offices. A report on the activity shall be submitted to the undersigned by the Information Systems Division fifteen (15) days after the conduct of the training.

The participation of all personnel concerned in the said activity shall be entitled with a one (1) day offsetting privilege to be used until December 31, 2022 in lieu of the Special Non-Working Holiday on December 8, 2022.

All expenses and cash advances to be incurred for this workshop shall be charged against KISS - DENR funds subject to the usual accounting and auditing rules and regulations. The Director of Knowledge and Information Systems Service is hereby authorized to adjust the date and venue of the activity as exigencies of the office may warrant
