SUBJECT : AUTHORIZING THE CONDUCT OF WORKSHOPS ON ACTION FOR CLIMATE EMPOWERMENT STRATEGY FRAMEWORK AND COMMUNITY LEVEL GREENHOUSE GAS INVENTORY ON NOVEMBER 29-DECEMBER 3, 2022 IN REGION 3
