AUTHORIZING THE CONDUCT OF THE NATIONAL BICYCLE DAY IN CELEBRATION OF THE CLEAN AIR MONTH ON 27 NOVEMBER 2022 AT MAKATI CITY HALL QUADRANGLE, MAKATI CITY

In the interest of service and by virtue of Presidential Proclamation No. 1052, and in celebration of the Clean Air Month, the conduct of National Bicycle Day is hereby authorized to be held on 27 November 2022, Sunday, at the Makati City Hall Quadrangle, Makati City to promote clean air in Metro Manila through the use of non-motorized modes of transportation and reduction of carbon emission in the environment.

The Strategic Communication and Initiatives Service (SCIS) shall supervise the participation of the DENR Contingent in the said event. The participation of all personnel concerned in the said activity shall be on official time with a one (1) day offsetting privilege to be used until 31 December 2022.

Observance of the minimum public health and safety protocols set by the Inter-Agency Task Force for the Management of Emerging Infectious Diseases shall be strictly imposed throughout the conduct of the activity.

Expenses to be incurred during the conduct of the event shall be charged against funds of the SCIS subject to the usual accounting and auditing rules and regulations.

The Undersecretary for Policy, Planning and International Affairs and Supervising Undersecretary for Strategic Communication and Initiatives Service is authorized to reschedule the activity in case of conflict with other activities of the Department.

A report shall be submitted to the undersigned within fifteen (15) days after the activity.

This Order takes effect on the date specified herein.
