SPECIAL ORDER

SUBJECT: AUTHORIZING THE CONDUCT OF DENR ASSESSMENT OF THE REMAINING BORACAY REHABILITATION ACTIVITIES ON MARCH 7-9, 2022 IN BORACAY ISLAND

In the interest of the service and in accordance with Executive Order No. 53 s. 2018, as amended by EO 115 s. 2020 and EO 147 s. 2021, the conduct of DENR assessment of the remaining Boracay rehabilitation activities which will be held on March 7-9, 2022, is hereby authorized in Boracay Island.

The DENR with BIARMG shall conduct an assessment to align the remaining activities, programs and projects mandated as per EO 53, s. 2018.

The BIATF Secretariat, DENR Region 6 and BIARMG shall facilitate and provide guidelines to assess the compliance and re-align the DENR activities, programs and projects (PPA's) per thematic areas involved under the Boracay Action Plan (BAP). This activity will also identify factors affecting the implementation of activities, identify and fast track those critical mandates before the end of the BIATF's term.
