AUTHORIZING THE CONDUCT OF THE 2<sup>nd</sup> NATIONAL RIVER BASIN SUMMIT

In the interest of service and in line with the mandate of the River Basin Control Office (RBCO) to lead the implementation of the Integrated River Basin Management Framework towards sustainable water sources for the protection of the environment and communities against flood and natural disasters, the 2<sup>nd</sup> National River Basin Summit with the theme "Accelerating Change through Partnerships and Cooperation" is hereby authorized to be conducted at Microtel, UP Technohub, Quezon City on 20-21 March 2023 through a blended learning set-up (face-to-face and virtual).
