SUBJECT: AUTHORIZING THE CONDUCT OF THE 1st DENR-PCMC BLOODLETTING ACTIVITY FY 2023 ON 24 MARCH 2023.

In the interest of the service and in view of the continuing partnership with the Philippine Children's Medical Center (PCMC) to save lives through blood transfusion and to generate adequate and safe blood supply in hospitals and other medical facilities, the conduct of the 1st DENR-PCMC Bloodletting Activity FY 2023 is hereby authorized on Friday, 24 March 2023 at the DENR Social Hall, 2nd Floor, DENR Main Building.

The following offices are authorized to mobilize their respective personnel to participate in the activity:

The Strategic Communication and Initiatives Service (SCIS) in partnership with the DENR Association of Career Executives (ACE) shall take the lead in the conduct of the overall activity and may coordinate with other concerned offices to join in the said activity.

Moreover, as this undertaking also coincides with the observance of Fire Prevention Month, representatives from the Bureau of Fire Protection shall participate in the activity.


Observance of minimum public health and safety protocols set by the Inter-Agency Task Force for the Management of Emerging Infectious Diseases such as wearing face masks and physical distancing shall be strictly imposed throughout the conduct of the activity.

All expenses to be incurred in the activity shall be charged against the funds of SCIS - Strategic Alliance and Environmental Partnership Division (SAEPD), subject to usual accounting rules and regulations.

Successful blood donors shall be entitled to a one-day offsetting privilege to be used until 30 June 2023.

The Undersecretary, Chief of Staff, and Supervising Undersecretary for Strategic Communications is hereby authorized to reschedule the activity in case of conflict with other activities of the Department.

This Order shall take effect on the date specified herein.
