## Duties and Responsibilities:

- 1. The Permanent Focal Person (PFP) shall oversee the 8888 referrals received by the DENR. She shall ensure and provide a specific action of 8888 referrals within 72 hours as prescribed by Executive Order No. 6, s. 2016.
- 2. The Alternate Focal Person (AFP), in the absence/in lieu of the PFP, shall act, monitor, and oversee the 8888 referrals received by the Office. The AFP shall assist the PFP in deciding the concrete and specific action on the 8888 referrals, and in ensuring compliance thereto.
- 3. The Technical Officer (TO) is in-charge of receiving 8888 referrals and in maintaining and managing the agency's 8888 online account/portal. The TO shall regularly check the 8888 portal, inform the PFP/AFP of received 8888 referrals, update, and provide feedback.
