In the interest of the service and in accordance with Executive Order No. 301 dated March 24, 2004, Establishing a Green Procurement Program (GPP) for all Departments, Bureaus, Offices and Agencies of the Executive Branch of the Government, the DENR Green Procurement Committee (DGPC) created under Special Order No. 2018-232, and reconstituted through Special Order No. 2020-294 and 2021-537 is hereby reconstituted as follows:

The Committee shall be guided by the policies of the Government Public Procurement Board (GPPB) in the conduct of its functions and the Green Procurement Roadmap as adopted by the GPPB. It shall provide directions/guidelines, approve environmental criteria for Common-Use Supplies (CSE) and Non-Common-Use Supplies (Non-CSE), approve policy and guidelines, and approve plans and programs.

The DGPPC Technical Working Group shall provide support to the committee, recommend environmental criteria for Common-Use Supplies and Non-Common-Use Supplies, recommend policy and guidelines, recommend plans and programs, and develop monitoring of Green Procurement Activities of the DENR Central Office. The DGPPC TWG may designate a permanent representative in writing who shall be allowed to attend, decide and vote on their behalf. They may recommend creation of sub-committees to the DGPPC members that may help in the implementation of the GPP Program and pursuit of its functions in the DENR Central Office.

The Secretariat shall assist the Committee in its technical and administrative tasks.

The DGPPC shall seek assistance from other units or offices of the DENR in the pursuit of its functions. All expenses of the Committee shall be charged against DENR funds subject to the usual accounting and auditing procedures.

This Order takes effect immediately and supersedes/amends Special Order Nos. 2018-232, 2020-294, 2021-537 and all orders inconsistent herewith.
