SUBJECT: AUTHORIZING THE CONDUCT OF THE 2023 DENR SPORTFEST

The Kalipunan ng mga Kawani sa Kagawaran ng Kalikasan (K4) National President and his/her designated K4 Lead Focal Persons shall facilitate the conduct of the said sportsfest in coordination with the concerned DENR Officials. They shall conduct meetings in the preparation of the said activity and oversee its implementation

Each Union President who will participate in said activity shall be the member of the technical committee and may designate a Sport Coordinator who will act as the working committee. He/she shall be responsible for the actions of their respective teams in the conduct of the said activities and shall report to their respective Head of Office the outcome of their participation.

Expenses to be incurred in the Inter Bureau/Agency shall be on equal sharing scheme of the participating teams in the amount of Eighty Thousand Pesos (Php 80,000.00) payable to the Kalipunan ng mga Kawani sa Kagawaran ng Kalikasan (K4).

DENR Attached Agencies, Bureau's and Regional Offices may also conduct their own sportsfest. All expenses related to their sportsfest activity shall be charged against their respective offices funds.

The Assistant Secretary for Human Resources, Strategic Communication and Sectoral Initiatives is hereby authorized to adjust the date of the subject activity if necessary through an Advisory Memorandum.

All expenses to be incurred in the said sportsfest and other expenses such as meetings, sports uniforms and other related and incidental expenses including the participating fee in the Inter-Bureau/Agency sportsfest shall be charged against their respective office funds, subject to the usual accounting and auditing rules and regulation and subject to the availability of their funds.

The DENR Inter-Bureau/Agency Sports Committee shall conduct a pre and post sports assessment workshop.

This Order takes effect only for the purpose and duration herein specified.
