SUBJECT: CREATION OF THE SECTORAL ASSESSMENT TEAMS FOR THE C.Y. 2022 ENVIRONMENTAL AWARDS FOR GOVERNANCE AND LEADERSHIP EXCELLENCE (EAGLE)

In the interest of the service and in order to facilitate and carry out the implementation of the 2022 EAGLE pursuant to Department Administrative Order DAO 2019-04, as amended by DAO 2021-18 relative to the Environmental Awards for Governance and Leadership Excellence (EAGLE), Sectoral Assessment Teams (SATs) are hereby created.

PHASE 1-A: Qualifying Validation

For qualifying validation, the Sectoral Assessment Teams (SATs) shall assess/validate the performance of the 16 Regional Offices based on their accomplishments on the various performance information indicators reflected in the General Appropriations Act (GAA) and Agency Accountabilities prescribed by AO 25 IATF.

The SATs shall identify indicators and formulate point systems; prepare documentation reports of the activity for the entire duration using the prescribed format; and present/submit to the Technical Working Group (TWG) the result of the rating and ranking of the top 5 regions. Phase 1-A shall be conducted from April to May 2023. The compositions of the Assessment Teams (SATs) are as follows:

PHASE 1-B: Ranking Validation

For ranking validation, the teams will assess and rank all Regional Key Officials (REDS, PENROs and CENROs) of the top 5 regions based on the result of Qualifying Validation. The following activities shall be undertaken by the team:

- a. Field validation of all CENROs and Implementing and Supervising PENROs from the qualified Regions based on their reported completed accomplishments; and
- b. Client Satisfaction Survey- focusing on the effectiveness of DENR Programs and Projects to the beneficiaries. This also includes partnerships and engagements with other government/non-government agencies and Local Government Units (LGUs).

All personnel under Contract of Service or Job Orders involved in the validation shall be entitled to a one-day offsetting privilege for every work rendered on Saturdays and Sundays during the fieldwork to be used until 31 December 2023.

The Undersecretary for Policy, Planning and International Affairs is authorized to amend the validation schedule and team composition hereof.

This order shall take effect immediately.
