SPECIAL ORDER NO. 2023 - 414

SUBJECT: RECONSTITUTION OF THE DENR CHANGE MANAGEMENT TEAM

In the interest of service, DENR Special Order No. 2022-407 dated 01 June 2022, reconstituting the DENR Change Management Team (CMT), is hereby affirmed with the following goals:

- 1. Compliance with the Implementing Rules and Regulations of Executive Order 366 for the conduct of a strategic review of the Department's operations;
- Conformity to the Commission on Audit and Department of Budget and Management Joint Circular No. 2, series of 2020 on the Updated Rules and Regulations Governing Contract of Service and Job Order Workers in the DENR:
- 3. Align the Department's organization and staffing with its growing mandate; and
- 4. Focus on outcome performance, change governance, and continual improvement to ensure the effective, efficient and sustainable accomplishment of the Department's mandate.

The DENR CMT shall have the following functions and responsibilities:

- Conduct a strategic review of the operations and organization of all component units of the Department under the current rationalized structure;
- 2. Identify the core functions, programs, activities and projects of the Department and its offices;
- 3. Identify areas of duplication and functions that are not responsible to the current interests of the Department.
- Identify the functions, programs, activities and projects which can be scaled down or those that need strengthening or where more resources need to be channeled;
- 5. Determine a more effective rationalized structure based on the assessment of the existing structure;
- 6. Recommend the issuance of policy/ies aimed at enhancing the existing structure; and
- 7. Perform other functions and tasks as the Secretary, DENR may direct.

A Technical Working Group (TWG) shall be created that shall assist the CMT in the performance of its functions. The TWG shall be composed of:
