**SUBJECT: AUTHORIZING THE CONDUCT OF THE 1<sup>st</sup> DENR-NKTI BLOODLETTING ACTIVITY ON 6 JULY 2023**

In the interest of the service and in line with the continuing partnership with the National Kidney and Transplant Institute (NKTI) to generate adequate safe blood supply in the hospitals and other medical facilities, the conduct of the 1<sup>st</sup> DENR-NKTI Bloodletting Activity in 2023 is hereby authorized to be held on Thursday, 6 July 2023 at the Main building lobby, DENR Central Office.

The Strategic Communication and Initiatives Service (SCIS) in partnership with the DENR Association of Career Executives (ACE) shall take the lead in the conduct of the overall activity and may tap the assistance of other concerned offices for this purpose.

Observance of minimum public health and safety protocols set by the Inter-Agency Task Force for the Management of Emerging Infectious Diseases such as wearing of face masks and physical distancing shall be strictly imposed throughout the conduct of the activity.

All expenses to be incurred in the activity shall be charged against the funds of SCIS - Strategic Alliance and Environmental Partnership Division (SAEPD), subject to usual accounting rules and regulations.

Successful blood donors shall be entitled to one day offsetting privilege to be used until 31 December 2023.

The Chief of Staff and Supervising Undersecretary for Strategic Communications are hereby authorized to reschedule the activity in case of conflict with other activities of the Department.

This Order shall take effect on the date specified herein.
