The members of the Philippine Plant Conservation Committee created under DENR Special Order No. 2013-71 dated 16 January 2013, as well as other interest groups from other government agencies, non-governmental organizations, academic institutions, and the private sector shall be enjoined to participate and/or serve as Resource Persons in the said Conference.

Expenses to be incurred in relation to the conduct of the above-said activity such as food, venue, and accommodation shall be chargeable against the BMB funds while travelling expenses and per diem of the participants shall be charged to their respective offices, subject to the availability of funds and to the usual accounting and auditing rules and regulations.

Rescheduling or further adjustments due to unforeseen events/circumstances, including the unavailability of venue or conflict with other activities of the DENR, are also authorized herein.

The BMB shall submit to the undersigned an activity report through the Human Resource Development Service within fifteen (15) days upon completion of the activity.

This Order takes effect on the dates specified therein.
