All expenses, but not limited to accommodation, food and travelling expenses, to be incurred for this activity shall be charged against the DENR CCS (PCRD) and GAD funds subject to the usual accounting and auditing rules and regulations.

All safety and health protocols, and prescribed minimum health standards shall be observed at all times despite lifting of national health emergency.

A report shall be submitted online (bit.ly/LNDportal) to the undersigned through the Human Resource Development Service (HRDS) - Training and Development Division, fifteen (15) days after the completion of the activity.

The Director of Climate Change Service is authorized to adjust the date and location of the subject activity as exigencies may warrant.

This Order shall take effect on the dates specified herein unless rescheduled.
