**SUBJECT: CREATION OF A COMPOSITE SURVEY TEAM TO CONDUCT THE DELINEATION SURVEY OF THE POLITICAL BOUNDARY BETWEEN THE PROVINCES OF NUEVA VIZCAYA AND PANGASINAN**

In the interest of the service and to complete the delineation of the political boundary between the Provinces of Nueva Vizcaya and Pangasinan as recommended by the Technical Working created pursuant to Special Order No. 2022-746 dated November 2, 2022, a Composite Survey Team is hereby created to be composed of the following:

The Composite Survey Team shall perform the following functions:

1. Verify the position of the three (3) major monuments (Pt. 26, K68, and Pt. Quimmalagon) including the intermediate points and other reference points, duly counter-check from different relevant monuments/references;

2. Coordinate with the concerned LGUs and Indigenous People's Municipal Representative (IPMR) on the conduct of the survey;
3. Submit the result of the survey to the Technical Working Group created under Special Order No. 2022-746 dated November 2, 2022 to serve as basis in the final recommendation on the delineation of the political boundary between the Provinces of Nueva Vizcaya and Pangasinan.

The DENR Regional Office I and II shall provide survey equipment and other logistical requirement.

The Composite Survey Team may request additional manpower from DENR Regions I and II in the conduct of the survey, such as brushes, haulers, and drivers.

All related expenses to be incurred by the Composite Survey Team including accommodation expenses, traveling expenses, per diems, and incidental expenses shall be charged against their respective Office's funds, subject to the usual accounting and auditing rules and regulations.

This order takes effect immediately and shall be automatically revoked upon completion of the task.
